Global Classes are divided into 3 different levels of use of a foreign language:

Level 1	<p>Mainly in Portuguese:</p> <ul style="list-style-type: none"> ➤ Teaching material and bibliographic resources in a foreign language; ➤ Lectures, classroom discussions and students' presentations in Portuguese, the use of a foreign language in the classroom being acceptable; ➤ Assessment (evaluations and assignments) in Portuguese; using a second language is acceptable if previously agreed between the student and the instructor.
Level 2	<p>Good balance between Portuguese and a foreign language.</p> <ul style="list-style-type: none"> ➤ Teaching material and bibliography resources in a foreign language; ➤ Lectures in a foreign language; both the foreign language and Portuguese are acceptable for classroom discussions and students' presentations, as mediated by the instructor; ➤ Assessment (evaluations and assignments) in Portuguese; using a second language is acceptable if previously agreed between student and instructor.
Level 3	<p>Entirely in a foreign language.</p> <ul style="list-style-type: none"> ➤ Teaching material and bibliographic resources in a foreign language; ➤ Lectures, classroom discussions and student presentations in a foreign language; ➤ Assessments (tests and assignments) in a foreign language.
